***Tobacco-Free/Nicotine-Free Policy guidelines for use with
Estherville Public Library***

Policy:

Estherville Public Library facilities and grounds, including vehicles owned or leased by Estherville Public Library, are off limits for tobacco/nicotine use. This includes but not limited to cigarettes, cigars, chewing tobacco, snuff, pipes, snus, Electronic Smoking Devices (ESD) and nicotine products that are not Food and Drug Administration (FDA) approved for tobacco cessation. This requirement extends to all employees, patrons and visitors. This policy applies at all times, including Estherville Public Library-sponsored and non- Estherville Public Library sponsored events. Persons failing to abide by this policy are required to extinguish their smoking material, dispose of the tobacco/nicotine product or leave [Estherville Public Library] premises immediately. It is the responsibility of the administration to enforce this policy.

Fact and Purpose:

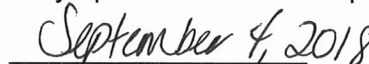
Estherville Public Library acknowledges that:

- a) Tobacco use is the single most preventable cause of death in the United States.¹
- b) Nonsmokers exposed to secondhand smoke are more likely to develop heart disease, lung cancer, and stroke^{2,3}; and
- c) Inhaling e-cigarette aerosol directly from the device or from secondhand aerosol is potentially harmful to health⁴; and
- d) Tobacco products (extends to all types of tobacco, nicotine and electronic smoking device (ESD) products), once consumed in public spaces, are often discarded on the ground requiring additional maintenance expenses and diminish the beauty of outdoor grounds; and
- e) The prohibition of tobacco and nicotine use at all times will serve to protect the health, safety and welfare of the citizens of our students, staff and visitors.

Effective Date:

This policy statement is effective immediately upon the date of adoption.

To ensure the Estherville Public Library has a strong tobacco-free/nicotine-free policy, and to qualify for free window clings and outdoor signage, the policy must explicitly include all of the following:

- ✓ Policy must extend to all types of tobacco, nicotine and ESD products (i.e. not only cigarettes; include all tobacco, ESDs and nicotine products not approved by the FDA for cessation.)
- ✓ Policy must extend to employees, students & visitors
- ✓ Policy must apply at all times, including Estherville Public Library-sponsored & non-Estherville Public Library-sponsored events
- ✓ Policy must extend to Estherville Public Library vehicles
- ✓ Policy must extend to entire Estherville Public Library property to receive outdoor signage
